# **Any Changes in Task Force** (e.g. member, action plan)

There is no change with the Task Force membership for the reporting period. In September meeting, the Richmond VisitAbility Task Force focused on the formulation of the Phase II Action Plan, which has been completed and submitted to the Project Team.

One Task Force member has been missing the past 3 meetings; coordinator will touch base with this individual to reaffirm his commitment.

# **Key Task Force Activities Done Since Last Report** (in a point format)

- On October 21, 2014, the Richmond Centre for Disability coordinated the hosting of the Webinar on Policy Development for VisitAble Housing at its centre for Richmond VisitAbility Task Force members. 6 members attended the webinar on site and the presentation was well received.
- Task Force Coordinator joined the Coordinators' Meeting conference call on November 7, 2014.
- One Task Force Meeting was held on November 18, 2014; a total of 16 participants 12 members plus one note taker, and three guests from RCD Board of Directors.
- A Phase II Action Plan has been completed, based on the inputs and commitments of the task force members.
- Distributed promotion materials at the RCD International Curling Bonspiel at the Richmond Curling Club from November 19 to 23, 2014.
- A presentation was delivered at the Urban Design Institute and City of Richmond Monthly Liaison Meeting on November 27, 2014 to developers and city managers. A package of promotional materials was assembled including Factsheets, VisitAble Housing Brochure, bookmark, pen, sticky note, as well as info on CCDS's Awards of Excellence in VisitAble Housing and information on the Richmond VisitAbility Task Force. Four task force members were at the presentation, and 9 developers and 10 city staff were present. The presentation agenda is attached with this report.
- A Task Force member touched base with Ontario Home Builders' Association regarding their "Accessibility Professional Designation" and their Accessible Residential Design curriculum.
- Distributed promotional materials at the RCD Open House on December 3, 2014 the UN International Day of Persons with Disabilities.
- Task Force Coordinator talked about VisitAble Housing, the project and the Awards of Excellence at a radio interview – AM1320, a Chinese broadcast radio station in Metro Vancouver. This is a very popular radio station among the Chinese community. The session lasted about 15 minutes.
